**AN ACT** to revive the National Institute of Cardiovascular Diseases (Sindh Administration) Act, 2014;

**Whereas**, in pursuance of the judgement of the Hon'ble Supreme Court of Pakistan dated the 17<sup>th</sup> January, 2019, where-under the National Institute of Cardiovascular Diseases (Sindh Administration) Act, 2014 (Sindh Act No.IV of 2015) was suspended and subsequent agreement the Federal Government and the Government of Sindh entered into an Agreement dated the 8<sup>th</sup> August, 2023, for the purpose of management and operational control of the Institute for a period of twenty-five (25) years;

**Preamble.**

And Whereas pursuant to the agreement dated 8<sup>th</sup> August, 2023, it is expedient to revive the National Institute of Cardiovascular Diseases (Sindh Administration) Act, 2014 (Sindh Act No.IV of 2015).

It is hereby enacted as follows:-

1. (1) This Act may be called the National Institute of Cardiovascular Diseases (Sindh Administration) Act, 2014 (Revival) Act, 2026. **Short title and commencement.**  
  
(2) It shall come into force at once.
2. (1) The National Institute of Cardiovascular Diseases (Sindh Administration) Act, 2014 (Sindh Act No.IV of 2015) in its original position as stood on 17<sup>th</sup> January, 2019, is revived with immediate effect in the light of the Agreement executed between the Federal Government and Government of Sindh, entered into on 8<sup>th</sup> August, 2023, for a term of twenty-five (25) years, for management and operational control of the Institute. **Revival of Sindh Act No.IV of 2015.**  
  
(2) Notwithstanding the revival under sub-section (1), the National Institute of Cardiovascular Diseases (Sindh Administration) Act, 2014 (Sindh Act No.IV of 2015) shall hold the field during the term of the Agreement referred to in sub-section (1).
3. Notwithstanding the revival of the national Institute of Cardiovascular Diseases (Sindh Administration) Act, 2014 (Sindh Act No.IV of 2015), all orders made, (including rules, bye-laws, regulations and notifications and other legal instruments), proceedings taken, appointments made, acts done by any authority or any person, which were made, taken or done, or purported to have been made, taken or done thereunder, between the 8<sup>th</sup> August, 2023, and the date on which this Act comes into force (both days inclusive) shall continue to remain in force, until altered, repealed or amended by the competent authority. **Saving.**
