SINDH ORDINANCE No. XIVOF 2000.

AN ORDINANCE

to amend the Sindh Irrigation Act, 1879.

WHEREAS it is expedient to amend the Sindh Irrigation Act, Preamble.

1879, in the manner hereinafter appearing;

AND WHEREAS the Provincial Assembly stands suspended in pursuance of the Proclamation of the fourteenth day of October, 1999, and the Provisional Constitution Order No. 1 of 1999;

AND WHEREAS the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the aforesaid Proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No. 9 of 1999, instructions of the Chief Executive and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance -

Short title and commencement

- This Ordinance may be called the Sindh Irrigation (Amendment) (1) Ordinance, 2000.
 - (2) It shall come into force on and from Kharif, 2000.

Amendment in 2. 1879.

- In the Sindh Irrigation Act, 1879, hereinafter referred to as the section 61 and said Act, in section 61, for the words "three months", the words "two years" and 62 of Act VII of for words "one thousand rupees", the words "ten thousand rupees" shall be substituted
 - In the said Act, in section 62, for the words "one year", the words "three years" and for the words "two thousand rupees", the words "twenty thousand rupees" shall be substituted.
 - 4. In the said Act, after section 62-A, the following new section shall be inserted:-

"62-B Non-bailable offence: An offence nunishable under section 61 or section 62 shall be non-bailable."
