**An ACT** to amend certain laws relating to the Public Universities and Institutes in force in the Province of Sindh.

**WHEREAS** it is expedient to amend certain laws relating to the Public Universities and Institutes in force in the Province of Sindh, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-
