**AN ACT** to provide for the establishment of the Aror University of Art, Architecture, Design and Heritage, Sukkur.

**WHEREAS** it is expedient to provide for the establishment of a University known as the *Aror University of Art, Architecture, Design and Heritage, Sukkur* and to provide for the matters connected therewith or ancillary thereto: **Preamble.**

It is hereby enacted as follows:-

## CHAPTER—I PRELIMINARY

1. (1) This Act may be called the *Aror University of Art, Architecture, Design and Heritage, Sukkur*, Act, 2019. **Short title and commencement.**

(2) It shall come into force at once.

2. In this Act unless there is anything repugnant in the subject or context— **Definitions.**

- (a) “Academic Council” means the Academic Council of the University;
- (b) “affiliated college” means a College affiliated to the University;
- (c) “Authority” means any of the Authorities of the University specified in section 22;
- (d) “Chancellor” means the Chancellor of the University;
- (e) “Chairman” means the head of a Teaching department established by the University;
- (f) “Chief Minister” means the Chief Minister of Sindh;
- (g) “College” means a college and includes an institution, in which arrangements exist for

imparting instructions or practical training, in courses of studies relating to art, architecture, design, heritages and such other allied subjects as may be prescribed;

- (h) “Commission” means the Sindh Higher Education Commission established under the Sindh Higher Education Commission Act, 2013 (Sindh Act No. XI of 2013);
- (i) “constituent college” means a college maintained and administered by the University;
- (j) “Dean” means the Head of a Faculty;
- (k) “Director” means the head of an institute established as constituent institute by the university;
- (l) “educational institution” means an institution imparting instruction in a subject or subjects relating to a faculty;
- (m) “Faculty” means a Faculty of the University;
- (n) “Government” means the Government of Sindh;
- (o) “Higher Education Commission Pakistan” means the Commission established under Higher Education Commission Pakistan Ordinance 2002;
- (p) “Honorary Professor” means a professor who provides academic services on honorary basis;
- (q) “Officer” means any of the officers of the University specified in section 9;
- (r) “prescribed” means prescribed by Statutes, Regulations or Rules;
- (s) “Principal” means the Head of a college;
- (t) “Pro-Chancellor” means the Pro-Chancellor of the University;

- (u) “Pro Vice-Chancellor” means the Pro Vice-Chancellor of the University;
- (v) “Professor Emeritus” means a retired Professor working in the University in an honorary capacity;
- (w) “registered graduate” means a graduate of the University whose name has been entered in the register maintained for this purpose and includes a graduate and post graduate in any of the subjects prescribed by or under this Act and residing within the territorial jurisdiction of the University and his name entered in the register maintained by the University for the purpose;
- (x) “Registrar” means the Registrar of the University;
- (y) “Regulations” means the Regulations made or deemed to have been made under this Act;
- (z) “Research Officer” means a person engaged whole-time by the University for research and equivalent in rank to a university Teacher;
- (aa) “Rules” means the Rules made or deemed to have been made under this Act;
- (bb) “Senate” means the Senate of the University;
- (cc) “Statutes” means the Statutes made or deemed to have been made under this Act;
- (dd) “Syndicate” means the Syndicate of the University;
- (ee) “Teacher” includes Professor, Associate Professor, Assistant Professor and Lecturer engaged whole time by University or by the college for imparting instructions in the University or a college on any prescribed course or courses and includes a person declared as such by Regulations;

- (ff) “Teaching Department”, means a Teaching Department established and maintained, or recognized by the University;
- (gg) “University” means the *Aror University of Art, Architecture, Design and Heritage, Sukkur*;
- (hh) “Vice-Chancellor”, means the Vice-Chancellor of the University;
- (ii) Visiting teacher” means a teacher who is invited for teaching by the University for a short period.

## CHAPTER—II THE UNIVERSITY

3. (1) The University to be called the Aror University of Art, Architecture, Design and Heritage, Sukkur is established in accordance with the provision of this Act. **Incorporation.**

(2) The University shall consist of –

- i. the Chancellor;
- ii. the Pro-Chancellor.
- iii. the Vice-Chancellor.
- iv. the Pro-Vice Chancellor, Deans, Principals of the colleges, Directors of the constituent institutions, Chairman of teaching departments, Registrar, Director Finance, Deputy Director Finance, Resident Auditor, Controller of Examinations, Project Director, Director Planning and such other officers as may be prescribed;
- v. the members of the Senate, the syndicate, the Academic Council and other Authorities of the University;
- vi. all University teachers; and
- vii. Professors Emeritus;

Provided that the Chief Minister may set up in any educational institution or college under the control and management of the

University and establish a Board of Governors under section 40, in lieu of the Officers and employees mentioned in sub-clause (b) of clause (1).

(3) The University shall be a body corporate having perpetual succession and a common seal with power among others, to acquire, hold and dispose of any property both movable & immovable vesting in it and shall by the aforesaid name sue and be sued.

(4) The University shall be competent to acquire and hold property, both movable and immovable, or lease, sell or otherwise transfer any moveable and immovable property which may have vested in or been acquired by it or enter into contract for the purpose of this Act.

4. (1) All properties and assets, right and interest of whatever kind, used, enjoyed, possessed, owned or vested in, or held in trust by the Quaid-e-Awam University of Engineering, Science and Technology in respect of Sindh College of Art and Design Sukkur and all liabilities legally subsisting against it immediately before the commencement of this Act, shall stand transferred to the University.

(2) All persons serving in the Quaid-e-Awam University of Engineering, Science and Technology in respect of Sindh College of Art and Design Sukkur in any capacity immediately before the commencement of this Act, if they opt to serve in the University, shall, notwithstanding any law or terms and conditions of their service, stand transferred for service to the University on the terms and conditions as may be prescribed:

Provided that such terms and conditions shall not be less favourable than the terms and conditions admissible to them immediately before their transfer.

(3) The option under sub-section (2) shall be exercised and submitted to Universities and Boards Department within ninety days of the commencement of this Act and the option so exercised shall be final.

- (i) to provide for instructions and research in, and advancement and dissemination of knowledge of, Art, Architecture, Design and Heritages including training, research, demonstration, diploma, certificates and such other allied subjects as may be prescribed;
  - (ii) to prescribe courses of studies to be taught in the University and colleges;

  - (vi) to provide for teaching specified courses or training for persons not being the students of the College, grant certificates and diplomas to such persons;
  - (vii) to affiliate or disaffiliate colleges in the prescribed manner;
  - (viii) to admit colleges to its privileges or withdraw such privileges from them in the prescribed manner;
  - (ix) to inspect colleges affiliated or seeking affiliation;

- (x) to conduct classes and confer degrees in subjects relating to Art, Architecture, Design<sup>1</sup>[Heritage, Sciences, Engineering and allied subjects];
- (xi) to accept the examinations passed or the periods of study spent at other college or places of learning, as equivalent to examinations or periods of study in the University or withdraw such acceptance;
- (xii) to cooperate with other colleges or universities or public authorities in such manner and for such purposes as it may determine;
- (xiii) to create posts in connection with teaching, research, extension, administration, training and for any other purposes related thereto and appoint persons there against;
- (xiv) to recognize any teacher of an affiliated college or such other person as teacher;
- (xv) to institute and award fellowships, scholarships, bursaries, medals and prizes in the prescribed manner;
- (xvi) to establish Teaching Department, colleges, faculties, institutes, centers of excellence, museums, art galleries and other centers of learning for the development of teaching and research and make such arrangements for their maintenance, management and administration, as it may determine;
- (xvii) to provide for instruction, training, research, demonstration, diploma, certificates and to award the degree under graduate and post graduate levels in the fields of art, architecture, design, <sup>2</sup>[heritage, sciences, engineering and allied subject] as prescribed;

- (xviii) to control the residence of the students of the University and the colleges, institute and maintain halls of residence and approve any place as hostel or lodging of students;
- (xix) to supervise and control the discipline of the students of the University and Colleges and promote the extra-curricular and recreational activities of such students and made arrangements for promoting their health and general welfare;
- (xx) to take disciplinary action against, and impose penalty on students in the prescribed manner;
- (xxi) to charge and receive such fees and other payments as it may determine;
- (xxii) to receive and manage property transferred, and grants, bequests, trusts, gifts, donations, endowments and other contributions made to the University, and invest any fund representing such property, grants, bequests, trusts, gifts, donations, endowments or contributions in such manner as it may deem fit;
- (xxiii) to provide for the printing and publication of research and other works; and
- (xxiv) to do such other acts or things, whether incidental to the power aforesaid or not, as may be necessary to further the objects of the College University as a place of education, learning and research, and as teaching, affiliating and examining body.

6. (1) Notwithstanding anything contained in any law, for the time being in force, the University shall have jurisdiction within the limit of its campus <sup>1</sup>[or campuses] and in respect of colleges in such areas within the Province of Sindh as may be notified by Government:
- Jurisdiction of the University.**

Provided that Government may, in consultation with the University, by general or special order modify the Jurisdiction.

(2) No educational institution situated within the territorial limits of the University shall, save with the consent of the University and the sanction of Government, be associated in any way with or seek admission to the privileges of any other University.

(3) The University may admit to its privileges under prescribed conditions, an educational institution falling within the territorial limits of another university whether inside or outside Pakistan, provided that the consent of such other University is first obtained.

7. (1) The University shall be open to all persons of either sex and of whatever religion, race, caste, creed, class or colour and no person shall be denied the privileges of the University on the grounds only of sex, religion, race, caste, creed, class or colour:
- University Open to all classes, creeds, etc.**

Provided that nothing in this section shall be deemed to prevent religious instruction being given to the students in their own religious faiths in such manner as may be prescribed.

(2) Government may issue guidelines and principles with respect to admission in the University including its constituent colleges and constituent institutions.

(3) The Academic Council shall frame admission policy in consonance with guidelines and principles.

8. (1) All recognized teaching in various courses in the University or the Colleges shall be conducted in the prescribed manner, and it may include lectures, tutorials, discussions, seminars, demonstrations, practical work in laboratories/studios/workshop and other methods of instruction.
- Teaching at the University.**

(2) The teaching in any prescribed course in the University or colleges shall be organized by such Authority as may be prescribed.

(3) The courses and the curricular for teaching in the colleges shall be such as may be prescribed. Provided that at the level of bachelor's degree, in all faculties a discipline to be called the Islamic and Pakistan Studies Discipline shall be compulsory for

Muslim students, and non-Muslim students shall in lieu of such discipline have option to offer Ethics and Pakistan Studies.

9. The following shall be the officers of the University:-

- (i) The Chancellor;
- (ii) The Pro Chancellor;
- (iii) The Vice Chancellor;
- (iv) The pro Vice-chancellor;
- (v) Deans;
- (vi) Principals of the colleges;
- (vii) Directors of the constituent institutions;
- (viii) Chairman of teaching departments;
- (ix) Registrar;
- (x) Director Finance **or Chief Financial Officer**;
- (xi) Chief Accountant;
- (xii) Resident Auditor;
- (xiii) Controller of Examinations;
- (xiv) Project Director;
- (xv) Director Planning;
- (xvi) Librarian;
- (xvii) and such other officers/members of the Authority as may be prescribed;

10. (1) The Governor of Sindh shall be the Chancellor of the **Chancellor**.  
University.

(2) The Chancellor shall, when present, preside at Convocation of the University.

(3) Every proposal to confer an honorary degree shall be subject to confirmation by the Chancellor.

(4) If the **Chief Minister** is satisfied that the proceedings of any Authority are not in accordance with the provisions of this Act, the statutes, the regulations, or the rules, he may, after calling upon such Authority to show cause why such proceedings should not be annulled, by order in writing, annul the proceedings.

(5) The **Chief Minister** shall have the power to assent to such statutes as are required to be submitted to him by the senate or withhold assent and refer them back to the senate for reconsideration.

(6) The **Chief Minister** may remove any person from the membership of any Authority if such person –

- (i) has become of unsound mind; or
- (ii) has been incapacitated to function as member of such Authority; or
- (iii) has been convicted by a court of law of an offence involving moral turpitude.

(7) The **Chief Minister** may, subject to the provisions of this Act, delegate all or any of the powers and functions of any Authority, officer or employee of the University at its main campus, to any authority, officer, employee or any other person at its additional campus for the purpose of exercising such powers and performing such functions in relation to such additional campus, and for this purpose the **Chief Minister** may create new posts or positions at the additional campus.

11. (1) The **Chief Minister** may cause an inspection or enquiry to be made in respect of any affairs or matter directly or in directly concerned with the University and shall, from time to time, appoint such person or more persons for of carrying out to conduct such inspection of **Visitation.**
- i. the university, its buildings, laboratories, studios libraries, museum, workshops and equipments;
  - ii. any institution college or hostel maintained or recognized by or affiliated to the University;
  - iii. the teaching and other work conducted by the University; and
  - iv. the conduct of examinations held by the University;
- (2) The **Chief Minister** shall, in every such case aforesaid, give notice to the Syndicate of his intention to cause an inspection or enquiry to be made, and Syndicate shall be entitled to be represented there-at.
- (3) The **Chief Minister** shall communicate to the Syndicate his views with regard to the results of such inspection or enquiry and shall, after ascertain the views thereon of the Syndicate, advice the Syndicate on the action to be taken.
- (4) The Syndicate shall communicate to the **Chief Minister** such action, if any, as has been taken or may be proposed to be taken upon the results of the inspection or inquiry within such time as may be specified by the **Chief Minister**.
- (5) Where the Syndicate does not, within a specified time, take action to the satisfaction of the **Chief Minister**, the **Chief Minister** may, after considering any explanation furnished or representation made by the Syndicate, issue such direction as he thinks fit, and the Vice Chancellor shall comply with such directions.
12. (1) The Pro-Chancellor of the University shall be a Minister or Advisor as may be nominated by the Chief Minister. **Pro-Chancellor.**
- (2) Should the Chancellor be incapacitated from acting as such

due to absence or any other cause, the Pro-Chancellor shall exercise all the powers and perform all the duties of the Chancellor.

13. (1) There shall be a Vice Chancellor of the University who shall be an eminent academic qualified to be full Professor and shall be appointed by the **Chief Minister** for a period of four years which may be extended for one more term only on such terms and conditions as the **Chief Minister** may determine. **Vice-Chancellor.**
  - (2) The Professional and Academic qualifications, experience and age for the post of Vice Chancellor shall be as such as may be determined by the **Chief Minister**.
  - (3) At any time when the office of the Vice Chancellor is vacant, or the Vice Chancellor is absent or is unable to perform the functions of his office due to illness or some other cause, the **Chief Minister** shall make such arrangements for the performance of the duties of the Vice-Chancellor.
  - (4) The Chief Minister shall, in case of allegations of gross misconduct, inefficiency, corruption, violation of budgetary provisions, moral turpitude, maladministration and mismanagement, remove the Vice Chancellor, on the basis of substantiated enquiry committee after giving him an opportunity of show cause notice against such removal.
  - (5) The Vice Chancellor may avail leave with the permission of Chief Minister or any other authority duly authorized by the Chief Minister.
14. (1) The Vice Chancellor shall be the principal executive and academic officer of the University, and shall ensure that the provisions of this Act, the statutes, the regulations and the rules are faithfully observed in order to promote the general efficiency and good order of the University. He shall have all powers necessary for this purpose including administrative control over all officers, teachers and other employees of the University. **Powers and Duties of the Vice chancellor.**
  - (2) The Vice Chancellor shall, in the absence of the Chancellor and Pro-Chancellor, preside at the Convocation of the University and the meetings of the Senate and shall, if present, preside at the meetings of the Authorities of which he is the Chairman and be entitled to attend and preside at any meeting of any other Authority or body of the University.

(3) The Vice Chancellor may, in an emergency, which in his opinion requires immediate action, take such action as he may consider necessary and shall, as soon thereafter as possible, report his action to the officer, authority or other body which in the ordinary course, would have dealt with the matter.

(4) The Vice Chancellor shall also have the powers –

- i. to create and fill temporary **“teaching”** posts for a period not exceeding six months; **“subject to final approval of the Syndicate”**;
- ii. to sanction all expenditure provided for in the approved budget, and to re-appropriate funds within the same major head of expenditure;
- iii. to sanction by re-appropriation of funds for an unforeseen item not provided for in the budget, and report it to the Syndicate at the next meeting;
- iv. to appoint paper setters **“jurors, panel of experts, art critics”** and examiners for all examinations of the University after receiving panels of names from the relevant authorities;
- v. to make such arrangements for the scrutiny of papers, marks and results as may be necessary;
- vi. to direct teachers, officers and other employees of the University to take up such assignments in connection with teaching, research, examination, administration and such other activities in the University as he may consider necessary for the purpose of University;
- vii. to delegate, subject to such conditions, if any, as may be prescribed, any of his powers under this Act to an officer or officers of the University;
- viii. to exercise general control supervision over the system of examination in the University;
- ix. to appoint employees of such categories in respect of which powers have been delegated to him by the Syndicate;

- x. to exercise and perform such other powers and functions as may be prescribed; and
- xi. to make appointments to the posts in all grades of the Basic Scales of pay up to grade 16.

(5) The Vice Chancellor shall present annual reports before the Senate within three months of close of the academic year. The annual report shall present such information as regards the academic years under review as may be prescribed, including disclosure of all relevant facts pertaining to the academics, research, administration and finances.

(6) The annual reports shall be made available prior to its presentation before the Syndicate to all officers and University teachers, and shall be published in such number as are required to ensure its wide circulation.

15. (1) The Pro-Vice Chancellor shall be from amongst the University Professors to be appointed by the **Chief Minister** for the main campus or of the additional campus, if any, or for both the campuses jointly or separately, on such terms and conditions and for such period not exceeding four years at time as may be determined by the **Chief Minister**. **Pro-Vice Chancellor.**

(2) Where a Pro-Vice Chancellor is appointed under subsection,(1), he shall, notwithstanding anything contained in this Act, exercise such powers and perform such functions of the Vice Chancellor or such other powers and functions, in respect of the campus for which he is appointed, as the **Chief Minister** may delegate to him.

(3) The Pro-Vice Chancellor, if appointed, shall be ex-officio member of the Senate, Syndicate and Academic Council.

16. (1) The Registrar shall be a whole-time officer of the University and shall be appointed by the Syndicate on the recommendations of the Selection Board, on such terms and conditions as it may determine **Registrar.**

(2) The Registrar shall –

- (a) hold office for a period of three years on the expiry of which he shall be eligible for re-appointment;

- (b) be the custodian of the common seal and the academic records of the University;
  - (c) maintain a register of registered graduates in the prescribed manner;
  - (d) conduct election of members to the various authorities in the prescribed manner; and
  - (e) perform such other duties as may be prescribed.
17. (1) The Director of Finance shall be a whole-time officer of the University and shall be appointed by **Chief Minister** from a panel of three candidates recommended by the Search Committee on such terms and conditions as it may determine. **Director of Finance.**
- (2) The Director Finance shall –
- (a) manage the property, finances and the investments of the University;
  - (b) be the Chief Finance officer of the University;
  - (c) prepare the annual and revised budget estimates of the University and present them to the Finance Committee, the Syndicate and the Senate;
  - (d) ensure that the funds of the University are expended for the purposes for which they are provided; and
  - (e) perform such other duties as may be prescribed.
- (3) The experience as well as professional and academic qualifications for the post of Director of Finance shall be such as may be prescribed.
- (4) The Director of Finance shall be assisted by the Chief Accountant, Bursar and the Resident Auditor.
18. The Controller of Examinations shall be a whole time officer of the University and shall be appointed by Syndicate on the recommendations of the Selection Board on such terms and conditions as it may determine. He shall be responsible for all matters connected with the conduct of examinations and perform such other duties as may be prescribed. **Controller of Examinations.**

19. (1) The Chief Accountant, <sup>1</sup>[\*\*\*] shall be whole-time officers of the University and shall be appointed by the Syndicate on the recommendations of the Selection Board on such terms and conditions as it may determine. **The Chief Accountant, Bursar and Resident Auditor.**
- (2) The Resident Auditor shall be whole-time officer of the University and shall be appointed by the Pro-Chancellor who shall be a Cabinet Minister on such terms and conditions as it may determine. 21. All the other remaining officers mentioned in section 9, shall be appointed by such officer or authority as authorized by Government on such terms and conditions as it may determine. They shall perform their duties as may be prescribed. **Other whole time Officers.**

(3) The members of the Senate, other than ex-officio members shall hold office for three years.

(4) The Senate shall meet at least twice in every year on dates to be fixed by the Vice Chancellor with the consent of the **Chief Minister**.

(5) The quorum for a meeting of the Senate shall be one-third of the total number of members, a fraction being counted as one.

24. Subject to the provisions of this Act, the Senate shall have the powers to – **Power and duties of the Senate.**

(xvi) one Principal of an affiliated college, if any, and the Principals of constituent colleges to the extent of the matters relevant to the concerned constituent college to be nominated by the Vice Chancellor;

(xvii) one Alim and one woman not serving in any educational institution to be nominated by the **Chief Minister**;

(xviii) one University officer of Administration side, to be elected from amongst all administrative officers.

(2) The members of the Syndicate, other than ex-officio members, shall hold office for three years.

(3) The quorum for a meeting of the Syndicate shall be one-half of the total number of members, a fraction being counted as one.

26. (1) The Syndicate shall be the executive body of the University and shall subject to the provisions of this Act and the statutes, exercise general supervision over the affairs and the property of the University. **Power and duties of the Syndicate.**

(2) Without prejudice to the generality of the foregoing powers, and subject to the provisions of this Act and the Statutes, the Syndicate shall have the powers—

(a) to determine the form, provide for the custody and regulate the use, of the common seal of the University;

- (e) to cause to be maintained books of accounts of all financial transactions including the assets and liabilities of the University;
- (f) to enter into, vary, carry out and cancel contracts on behalf of the University;
- (g) to provide buildings and other premises, libraries, furniture, apparatus, equipment and such other things required for the University;
- (h) to establish and maintain halls of residence and hostels for students and approve any place as hostel or lodging of students;
- (i) to affiliate and disaffiliate colleges;
- (j) to admit colleges and educational institutions to the privileges of the University and withdraw such privileges;
- (k) to cause inspections to be made of the colleges and the Teaching Department;
- (l) to create posts in connection with teaching, research, extension, administration, training and for any other purposes related thereto;
- (m) to appoint, on the recommendation of the Selection Board, University Teachers and employees to posts in Basic Scale 17 and above;
- (n) to appoint Professors Emeritus on such terms and conditions as may be prescribed;
- (o) to suspend, punish and remove from service, officers (other than the Vice Chancellor), Teachers, and other employees in the manner prescribed;

- (s) to consider and approve regulations proposed by the Academic Council, or frame regulations after calling the advice of the Academic Council;

- (u) to furnish report on any matter called for by the Senate;

(2) The members appointed other than the ex-officio members shall hold office for three years.

28. (1) The Academic Council shall be the academic body of the University and shall, subject to the provisions of this Act the statutes and the regulations, have the powers to lay down proper standards of instructions, research, and examinations and to regulate and promote the academic life of the University and the colleges.
- Powers and duties of the Academic Council.**
- (2) Without prejudice to the generality of the foregoing powers, and subject to the provisions of this Act the statutes and the regulations, the Academic Council shall have the powers –
- (a) to advise the Syndicate on academic matters;

(2) The Syndicate shall make a proposal for any statutes to the Senate which may after considering the proposal, approve it with or without any modifications or refer it back to the syndicate for reconsideration, or reject it:

Provided that the statutes affecting the constitution or powers of the Authority shall not be proposed until such Authority has been given an opportunity of expressing its opinion in writing on the proposal:

Provided further that the statutes in respect of any matter mentioned in clause (a) of sub-section (1), passed by the Senate shall not be affective until they have been approved by the **Chief Minister**:

Provided also that statutes in respect of the matter mentioned in clause (j) shall be made by the **Chief Minister**.

32. (1) Subject to the provisions of this Act and the statutes, **Regulations.** regulations may be made for all or any of the following matters, namely:-

- (a) the courses of studies for degrees, diplomas and certificates of the University;

- (i) the institution of fellowships, scholarships, exhibitions medals and prizes;
- (j) the academic costumes;
- (k) the use of Library;
- (l) the formation of Teaching Departments and Board of Studies; and
- (m) all other matters which by this Act, or statutes are to be or may be prescribed by the regulations.

(2) The Academic Council shall prepare and submit the regulations to the Syndicate, which may approve them with or without modifications or refer them back to the Academic Council for reconsideration, or reject them.

33. (1) The Authorities and the other bodies of the University may make rules consistent with this Act, statutes and the regulations, to regulate the conduct of their business and the time and place of meetings and related matters: **Rules.**

Provided that the Syndicate may direct the amendment or the annulment of any rules, made by any Authority or body excepting the Senate, under this section:

Provided further that if such other Authority or body is dissatisfied with such direction it may appeal to the Senate whose decision in the matter shall be final.

(2) The Syndicate may make rules to regulate any matter relating to the affairs of the University which has not been specifically provided for by this Act, the statutes or regulations.

34. The procedure for adding to, amending or repealing the statutes and the regulations shall be the same as that prescribed respectively for framing or making statutes and regulations. **Amendment and repeal of statutes and regulations.**
35. (1) An educational institution applying for affiliation to the University shall make an application to the University and shall satisfy it – **Affiliation.**
- (i) that the educational institution is under the management of the Government or of a regularly constituted governing body;
  - (ii) that the financial resources of the educational institution are sufficient to enable it to make due provision for its continued maintenance and efficient working;
  - (iii) that the strength and qualifications of the teaching and other staff, and the terms and conditions of their service, are adequate to make due provision for the courses of instruction, teaching or training to be undertaken by the educational institution;
  - (iv) that the educational institution has framed proper rules regarding the efficiency and discipline of its staff and other employees;
  - (v) that the building in which the educational institution is to be located is suitable, and that provision will be made inconformity with the statutes and the regulations for the residence of students, not residing with their parents or guardians, in the hostels established and maintained by the educational institution or in hostels or lodgings approved by it, and the supervision and physical and general welfare of students;
  - (vi) that provision has been made for Library and adequate library services;
  - (vii) that where affiliation is sought in any branch of experimental sciences, due arrangements have been made for imparting instruction in that branch of science in a properly equipped

laboratory, museum and other places of practical work;

- (viii) that due provision will, so far as circumstances may permit, be made for the residence of Principal and members of the teaching staff in or near the college or the place provided for the residence of students; and
- (ix) that the affiliation of the educational institution, having regard to the provision which may have been made for students by another educational institution in its neighborhood, will not be injurious to the interests of education or discipline.

(2) The application shall further contain an undertaking that after the educational institution is affiliated any transference of, and changes in the management and in the teaching staff shall be forthwith reported to the University, and that the teaching staff shall possess such qualifications as are or may be prescribed.

(3) The procedure to be followed in disposing of an application for the affiliation of an educational institution shall be such as may be prescribed.

(4) The Syndicate may, on the recommendation of the Affiliation Committee, grant or refuse affiliation to an educational institution:

Provided that affiliation shall not be refused, unless the educational institution has been given an opportunity of making a representation against the proposed decision.

(2) The University may call upon any educational institution affiliated to it to take, within a specified period, such action as may appear to the University to be necessary in respect of any of the matters referred to in sub-section (1) of section 35.

38. (1) If an educational institution affiliated to the University fails at any time to fulfill any of the requirements mentioned in this Act, or if an institution has failed to observe any of the conditions of its affiliation, or its affairs are conducted in a manner which is prejudicial to the interest of education, the Syndicate may, on the recommendation of the Affiliation Committee, and after considering such representation as the educational institution may wish to make, withdraw, either in whole or in part, the rights conferred on the educational institution by affiliation or modify such rights. **Withdrawal of affiliation.**
- (2) The procedure to be followed for the withdrawal of affiliation shall be such as may be prescribed.
39. An appeal shall lie to the Senate against the decision of the Syndicate refusing to affiliate an institution, or withdrawing in whole or in part the rights conferred on an institution by affiliation or modifying such rights. **Appeal against refusal or withdrawal of affiliation.**
40. (1) The **Chief Minister** may, on request of any affiliated institution or college direct that the control and management of such educational institution or college may be taken over by the University. **Taking over of institution or college.**
- (2) The **Chief Minister** may, for the efficient management and control of such educational institution or college, establish a Board of Governors.
- (3) The Board of Governors shall consist of –
- (i) the Pro-Chancellor **Chairperson**
  - (ii) the Vice-Chancellor **Vice-Chairperson**
  - (iii) such other Members as may be appointed by the **Chief Minister** in consultation with Vice-Chancellor.
- (4) Subject to special or general direction of the **Chief Minister** the Board of Governors shall exercise general supervision and

control over the affairs of such institution or college and without prejudice to the generality of these powers it shall –

- (i) formulate the policy for running the institution or college in the light of guide lines issued by the University from time to time;
- (ii) control and administer the property of the institution or college;
- (iii) manage and regulate the funds, finances, assets and investments of the institution or college;
- (iv) maintain the accounts of the institution or college in the prescribed form and get such accounts audited in the prescribed manner; and
- (v) appoint teachers and other employees of the institution or college and have the power to take disciplinary action against them.

## CHAPTER—VI UNIVERSITY FUND

41. There shall be fund for the University to be called the University Fund to which shall be credited all moneys received by the University from fees, donations, trusts, bequests, endowments, contributions, grants and other sources. **University Fund.**
42. (1) The accounts of the University shall be maintained in such form and in such manner as may be prescribed. **Audit and Accounts.**
- (2) No expenditure shall be made from the funds of the University unless a bill for its payment has, in accordance with the statutes, been audited by the Resident Auditor and the payment is included in the approved budget of the University.
- (3) The accounts of the University shall, in the prescribed manner, be audited once a year by the Auditor appointed by the Syndicate.
- (4) The annual statement of the accounts of the University signed by the Director of Finance and the Resident Auditor shall

be submitted to Government within six months of closing of the financial year.

(5) The accounts of the University together with audit objections, if any, and the observations of the Government Auditor and the Director of Finance shall, in the prescribed manner, be presented to the Syndicate.

## CHAPTER—VII GENERAL PROVISIONS

43. An officer, teacher or other employee of the University shall retire from the service of the University – **Retirement from service.**
- (i) on such date, after he has completed twenty five years service qualifying for pension or other retirement benefits, as the competent authority may direct: Provided that no employee shall be retired unless he has been informed in writing of the grounds of the action proposed to be taken against him and has been given reasonable opportunity of showing cause against that action; or
- (ii) where no direction is given under clause (i), on the completion of sixty years age. Explanation: In this section “competent authority” means the appointing authority or a person duly authorized by the appointing authority in that behalf, not being a person lower in rank to the officer, teacher or other employee concerned.
44. Except as otherwise provided in this Act, no officer, teacher or other employee of the University holding a permanent post shall be reduced in rank, or removed or compulsorily retired from service, unless he has been given reasonable opportunity of showing cause against the action proposed to be taken against him **Opportunity to show cause.**
45. (1) Where an order is passed punishing any officer (other than the Vice Chancellor), teacher or other employee of the University or altering or interpreting to his disadvantage the prescribed terms or conditions of his service, he shall, where the order is passed by the Vice Chancellor or any other officer or **Appeal to review.**

(2) The appeal or application for review shall be submitted to the Vice Chancellor and he shall lay it before the Syndicate with his views along with the record of the case.

(3) No order in appeal or review shall be made unless the appellant or the applicant, as the case may be, has been given an opportunity of being heard.

46. (1) The University shall constitute for the benefit of its officers, teachers and other employees in such manner and subject to, such conditions as may be prescribed, such pension, insurance, gratuity, provident funds and benevolent fund scheme as it may deem fit. **Pension Insurance, Gratuity Provident Fund and Benevolent Fund.**
- (2) Where any provident fund has been constituted under this Act, the provisions of the Provident Funds Act, 1925 (Act No.XIX of 1925) shall apply to such funds as if it were the Government Provident Fund.
47. (1) When a member of a newly constituted Authority is elected, appointed or nominated, his term of office, as fixed under this Act, shall commence from such date as may be prescribed. **Commencement of term of office of members of Authority.**
- (2) Where a member nominated or elected to any Authority, fails to attend three meetings consecutively, he shall cease to be the member.
- (3) Where a member who has accepted any assignment or for any such other reason, remain absent from the University for a period not less than six months, he shall be deemed to have resigned and vacated his seat.
48. Any casual vacancy among the elected, appointed or nominated members of any Authority shall be filled, as soon as conveniently may be, by the person or persons or the body who elected, appointed or nominated the member whose place has become vacant and the person elected, appointed or nominated to vacancy, shall be a member of such Authority for the residue of the term for which the person whose place he fills would have been a member. **Filling of casual vacancies in Authorities.**

Chairmen of the Teaching Departments

- (c) one member of each Board of Studies comprised in the Faculty to be nominated by the Board of Studies concerned; and
- (d) three teachers to be nominated by the Academic Council by reason of their specialized knowledge of subjects which, though not assigned to the Faculty, have in the opinion of the Academic Council, important bearing on the subjects assigned to the Faculty.

(4) The members mentioned in sub-clauses (c) and (d) of clause (3) shall hold office for three years.

(5) The quorum for a meeting of the Board of a Faculty shall be one-half of the total number of members, a fraction being counted as one.

(6) The Board of each Faculty shall, subject to the general control of the Academic Council and the Syndicate, have the powers –

- (a) to coordinate the teaching and research work in the subject assigned to the Faculty;
- (b) to scrutinize the recommendations of the Board of Studies comprised in the Faculty, on the appointment of paper setters and examiners, except for research examiners and forward them to the Vice Chancellor;
- (c) to consider any other academic matter relating to the Faculty and to report thereon to the Academic Council; and
- (d) to perform such other functions as may be prescribed

(3) The term of office of members of the Board of Studies other than ex- officio members shall be three years.
