AN ACT to amend the Provincial Motor Vehicles Ordinance, 1965.

WHEREAS it is expedient to further amend the Provincial Motor Vehicles Ordinance, 1965, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-

1. (1) This Act may be called the Provincial Motor Vehicles (Amendment) Act, 2026. **Short title and commencement.**

(2) It shall come into force at once.

2. In the Provincial Motor Vehicles Ordinance 1965, hereinafter referred to as the said Ordinance, after section 67-G, the following new sections shall be inserted:- **Insertion of new section 67-H and 67-I in the West Pakistan Ordinance No.XIX of 1965.**

67-H. Mandatory third party liability motor insurance.
 Notwithstanding anything contained in this Ordinance, no motor vehicle shall be registered under section 23 or granted transfer of ownership under section 32, and/or alteration and annual tax payment under relevant taxation law and rules, by the registration authority unless the motor vehicle except two wheelers or motorcycles holds a valid policy of third party insurance, which covers third party risk by providing the irrevocable option of claim payment to the injured person(s) or legal heirs as the case may be, through payment of claim without intervention of the court on no-fault basis as per the limits specified in the Sixteenth Schedule by an insurer registered under the Insurance Ordinance, 2000.

67-I Compensation for the death of or injury to a passenger.
 In the case of death of, or injury to a person, in an accident by a vehicle covered under motor third party liability insurance under section 67-H, shall be paid by the respective insurer as compensation amount as specified in the Sixteenth Schedule within forty-five days (45) days or within such period as specified in the Insurance Ordinance, 2000 whichever is earlier.

3. In the said ordinance, after Fifteenth Schedule, the following new Schedule shall be added:- **Insertion of new Schedule in the West Pakistan Ordinance No.XIX of 1965.**

SIXTEENTH SCHEDULE

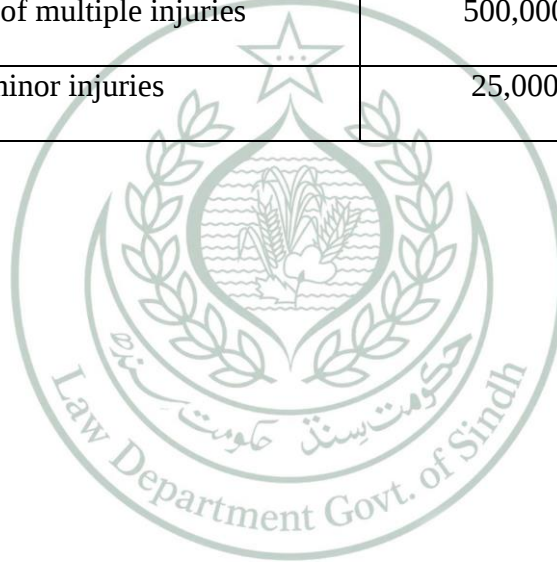

Scale of Compensation payable on injuries deemed to result in permanent disability to a Person injured in an accident by the vehicle / contract carriage covered under Motor Third Party Liability Insurance.

S#	Description of Injuries	Minimum Compensation
1.	Death	700,000
2.	Loss of both hands	500,000
3.	Loss of both arms	500,000
4.	Loss of both feet	500,000
5.	Loss of both legs	500,000
6.	Complete and irrecoverable loss of sight in both eyes	500,000
7.	Loss of one hand and one foot	500,000
8.	Loss of one hand, one foot with complete loss of sight in one eye	500,000
9.	Complete and incurable insanity	500,000
10.	Complete and incurable paralysis	500,000
11.	Complete and irrevocable loss of hearing in both ears	500,000
12.	Loss of right arm or hand	450,000
13.	Loss of left arm or hand	400,000
14.	Loss of one leg or foot	400,000
15.	Complete and irrecoverable loss of sight in one eye	250,000
16.	Loss of thumb of right hand	150,000
17.	Loss of thumb of left hand	100,000

24.	Complete and irrevocable hearing in one ear	100,000
25.	In case of multiple injuries	500,000
